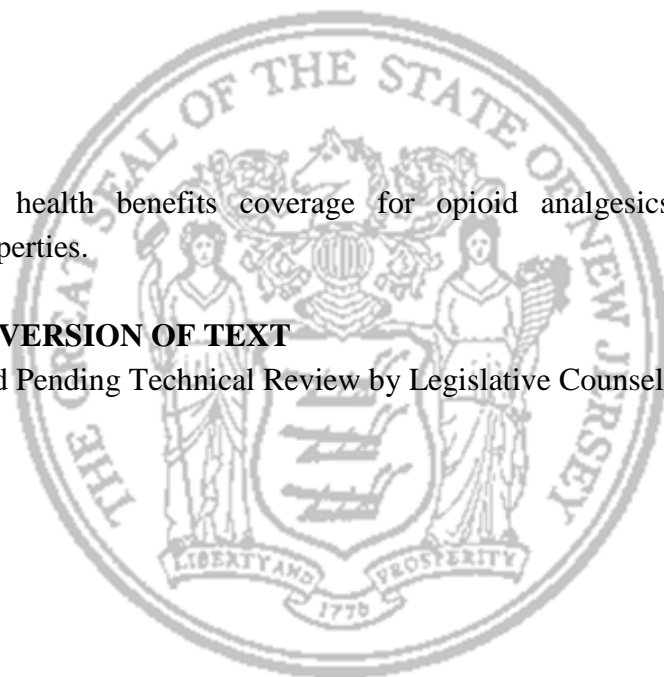

SYNOPSIS

Mandates health benefits coverage for opioid analgesics with abuse-deterrent properties.

CURRENT VERSION OF TEXT

1 AN ACT concerning health benefits coverage for opioid analgesics
2 with abuse-deterrent properties and supplementing various parts
3 of the statutory law.
4

5 **BE IT ENACTED** by the Senate and General Assembly of the State
6 of New Jersey:
7

8 1. a. A hospital service corporation contract that provides
9 hospital or medical expense benefits and is delivered, issued,
10 executed or renewed in this State, or approved for issuance or
11 renewal in this State by the Commissioner of Banking and
12 Insurance, on or after the effective date of this act, shall provide
13 coverage on its formulary, drug list, or other lists of similar
14 construct for at least one prescribed abuse-deterrent opioid
15 analgesic drug product per opioid analgesic active ingredient,
16 subject to the following requirements:

17 (1) Cost sharing for brand name abuse-deterrent opioid
18 analgesic drug products covered pursuant to this subsection shall
19 not exceed the lowest cost sharing level applied to brand name non-
20 abuse deterrent opioid drugs covered under the applicable contract;

21 (2) Cost sharing for generic abuse deterrent opioid analgesic
22 drug products covered pursuant to this subsection shall not exceed
23 the lowest cost sharing level applied to generic non-abuse deterrent
24 opioid drugs covered under the applicable contract;

25 (3) An increase in patient cost sharing or disincentives for a
26 prescriber or dispenser shall not be allowed to achieve compliance
27 with this section; and

28 (4) Any prior authorization requirements or other utilization
29 review measures for opioid analgesic drugs, and any service denials
30 made pursuant thereto, shall not require first use of non-abuse-
31 deterrent opioid analgesic drugs in order to access opioid analgesic
32 drugs with abuse-deterrent properties. Nothing in this subsection
33 shall be construed to prevent the application of prior authorization
34 requirements to abuse-deterrent opioid analgesic drugs, provided
35 that those requirements are also applied to non-abuse-deterrent
36 versions of that opioid.

37 b. The provisions of this section shall apply to all hospital
38 service corporation contracts in which the hospital service
39 corporation has reserved the right to change the premium.

10 renewal in this State by the Commissioner of Banking and
11 Insurance, on or after the effective date of this act, shall provide
12 coverage on its formulary, drug list, or other lists of similar
13 construct for at least one prescribed abuse-deterrent opioid
14 analgesic drug product per opioid analgesic active ingredient,
15 subject to the following requirements:

16 (1) Cost sharing for brand name abuse-deterrent opioid
17 analgesic drug products covered pursuant to this subsection shall
18 not exceed the lowest cost sharing level applied to brand name non-

45 This bill requires health insurers to provide health benefits
46 coverage for prescribed abuse-deterrent opioid analgesic drugs.
47 Opioid analgesic drugs are drugs prescribed to treat moderate to severe
48 pain or other conditions. Abuse-deterrent opioid analgesic drugs are a

1 brand or generic opioid analgesic drug approved by the United States
2 Food and Drug Administration with abuse-deterrence labeling claims
3 indicating its abuse-deterrent properties are expected to deter or reduce
4 its abuse.

5 The bill requires health insurers to provide coverage on the
6 insurer's formulary, drug list, or other lists of similar construct, for at
7 least one prescribed abuse-deterrent opioid analgesic drug product per
8 opioid analgesic active ingredient, subject to the following:

9 (1) Cost sharing for brand name abuse-deterrent opioid analgesic
10 drug products is not to exceed the lowest cost sharing level applied to
11 brand name non-abuse deterrent opioid drugs covered under the
12 applicable contract;

13 (2) Cost sharing for generic abuse deterrent opioid analgesic drug
14 products is not to exceed the lowest cost sharing level applied to
15 generic non-abuse deterrent opioid drugs covered under the applicable
16 contract;

17 (3) An increase in patient cost sharing or disincentives for a
18 prescriber or dispenser will not be allowed to achieve compliance with
19 the bill's provisions; and

20 (4) Any prior authorization requirements or other utilization
21 review measures for opioid analgesic drugs, and any service denials
22 made pursuant to such requirements or measures, may not require first
23 use of non-abuse-deterrent opioid analgesic drugs in order to access
24 opioid analgesic drugs with abuse-deterrent properties.

25 The bill applies to health, hospital and medical service
26 corporations; commercial individual and group health insurers; health
27 maintenance organizations; health benefits plans issued pursuant to the
28 New Jersey Individual Health Coverage and Small Employer Health
29 Benefits Programs; the State Health Benefits Program; and the School
30 Employees' Health Benefits Program.
